BOARD OF ALDERMEN REGULAR SESSION MINUTES
WEDNESDAY, AUGUST 20, 2025

The Board of Aldermen held their meeting in the City Hall boardroom located at 5490 5th Street Cottleville, Missouri.

Mayor Stephen Thompson called the meeting to order at 7:11 p.m. and the pledge of allegiance was recited.

Mayor's Report

Mayor Thompson announced the names of those recently recognized at the Purple Heart luncheon held at City Hall. He also announced that although the local businesses have not been in violation of the noise ordinance, he asked that they work together with the community in a respectful way to continue quality of life for area residents. In addition, Mayor Thompson thanked Michael Padella for submitting a recent invoice for streetlights to the Old Town CID.

Public Hearings

A. A Public Hearing for a Request for Rezoning of a tract of land located at 3998 Mid Rivers Mall Drive, Cottleville, MO 63376, from R1-A "Single Family Residential District to RD "Recreational District" (Project Name: Impact City FC Soccer Complex; Applicant: Vessel Architecture on behalf of Impact City FC).

Alderman Holt moved to open public hearing item A above. Alderman Krekeler seconded the motion. Motion was carried by affirmative votes of three (3) Aldermen. There were no nay votes and no abstentions.

Peter Schwartz with Vessel Architecture and Jamie Wagner, owner presented the plan for Impact Soccer to allow for improved fields, lights and a concession building with a bit of retail that would be home to the faith-based soccer program. The applicant stated they plan to build this in phases. It was noted a traffic study and light study would be required. The applicant stated CBB has started on the traffic study already.

Brad Aslin of Calvary Church spoke in support of the project and stated the congregation and church board are also in full support.

Stephen Savage, 1155 Motherhead Road stated his daughters are in the Impact Soccer program and would love to be able to stay in Cottleville instead of driving to Maryland Heights or Chesterfield for games and practices.

Terry Hogan, 399 Weiss Road spoke in favor of the project but requested the logo and branding say Cottleville Campus instead of St. Louis.

Alderman Guccione moved to close public hearing item A above. Alderman Krekeler seconded the motion. Motion was carried by affirmative votes of three (3) Aldermen. There were no nay votes and no abstentions.

Alderman Holt moved to open public hearing item C above. Alderman Guccione seconded the motion. Motion was carried by affirmative votes of three (3) Aldermen. There were no nay votes and no abstentions.

Micah Raposo, the applicant, was present at the meeting to describe his desire to open a Men’s Modern General Store by August 30th therefore he would like to request two readings tonight. He further described his desire to sell high quality men’s items and gifts often made the USA such as; wallets, watches, knives, cutting boards, small batch bourbon, BBQ supplies, beard/hair supplies and maybe cigars in the future. He also provided a revised handout.

A Public Hearing for a Conditional Use Permit (CUP) Request for a new “Medical Hospital and Clinic” on Lot C of the Miralago Subdivision at the intersection of Mid Rivers Mall Drive and Miralago Way in Cottleville, MO 63376 (Project Name: “St. Lukes MOB Clinic” Applicant: Stock & Associates Consulting Engineering, Inc on behalf of St. Luke’s Medical Group).

Alderman Guccione moved to open public hearing item D above. Alderman Krekeler seconded the motion. Motion was carried by affirmative votes of three (3) Aldermen. There were no nay votes and no abstentions.

Allison Gauch with Stock & Associates presented the plan for St. Luke’s to erect a new medical building. Ms. Gauch provided a slide presentation with building elevations, landscaping and more. It was noted that the building will have eight exam rooms.

Parking (Lot)" at 6494 Highway N, Cottleville, MO 63304 (Project Name: "Cottle Village Overflow Parking Lot West" ; Applicant: Cottlevillage Land Group, LLC).

Alderman Holt moved to open public hearing item E above. Alderman Guccione seconded the motion. Motion was carried by affirmative votes of three (3) Aldermen. There were no nay votes and no abstentions.

Stephen Savage, applicant and owner presented his request to provide an additional parking lot at Cottle Village adding 255 spaces. He stated they currently have been using shuttles and erecting no parking signs on Highway N and neighboring streets. He stated employees will park the furthest away and kitchen staff are commonly gone by 9pm.

Alderman Guccione stated this is a public safety issue and appreciated the applicant getting this addressed. It was noted the new parking lot lighting will be up and working even during the initial phase of being gravel. However, it was also noted the parking lot is required to be concrete or asphalt within 12 months.

Alderman Krekeler moved to close public hearing item E above. Alderman Guccione seconded the motion. Motion was carried by affirmative votes of three (3) Aldermen. There were no nay votes and no abstentions.

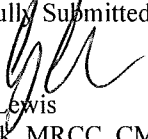

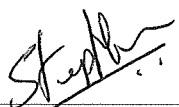

AUGUST 20, 2025

The Board of Aldermen held their meeting at City Hall located at 5490 5th Street Cottleville, Missouri.

Mayor Thompson called the meeting to order at 5:30p.m.

There were three (3) members present and one (1) absent.

Staff Reports

A. City Administrator

During this time, Michael Padella, City Administrator, updated the Board of Aldermen on all agenda items including the consent agenda items, proclamation and all the public hearing items. Discussion and review was held regarding the new St. Lukes Medical building, Impact City FC soccer Complex rezoning and the Men's Modern General Store conditional use permit on tonight's agenda. It was noted that the Men's Modern General Store would be selling various men's gifts and specialty items such as; clothing, knives, wallets, watches, BBQ items, spices, beard care items and more. However, they would like to also sell and offer tastings of small batch bourbons not typically sold in big box stores. It was the consensus of the PZ Commission to recommend they only allow liquor sales on the first floor, be 50% of the total sales and encompass up to 10% of the floor area. Some discussion was held regarding conditional uses continuing with the property and not the business itself which is by Missouri State Statute. Mayor Thompson and Alderman Guccione suggested the City investigate conditional uses continuing with a business rather than the property. However, Drew Weber, City Attorney did not recommend moving forward with that for Cottleville, a 4th class City. It was also noted the City is working on a list of conditional uses that go along with each property in the City which would include age documents or old information. Alderman Krekeler and Alderman Holt had concerns with allowing a conditional use for any liquor sales at all at 5208 Highway N. Alderman Holt inquired if the City could approve a men's general store marketed toward men only. Alderman Guccione suggested separating the retail portion vs. the liquor sales of the conditional use in order to not hold the applicant up from opening.

Next the Board of Aldermen reviewed the parking lot addition for Cottle Village. It was noted two readings may be needed due to safety concerns with overflow parking on neighboring roads and streets.

Alderman Guccione moved to suspend the rules for Bills 25-033. Alderman Krekeler seconded the motion. Motion was carried by affirmative votes of three (3) Aldermen. There were no nay votes and no abstentions.

At this time, Mr. Padella began reviewing the ordinances pertaining to code changes such as regulating storage or shipping containers and providing fence permits. Alderman Krekeler suggested the bill on tonight's agenda did not accomplish regulating shipping containers. Mr. Padella stated some clean up still needs to be done on the bill regulating fences such as providing for a permit process, allowing wrought iron style fencing, variations on commercial lots and large residential lots vs subdivision lots. Mr. Padella also reviewed the bills on tonight's agenda updating the validity period for conditional uses, granting Spire an additional easement, reclassifying multifamily-senior housing for solid waste purposes, allowing archway signage, updating medical office use and senior living parking requirements and updating construction escrows requirements.

In addition, Mr. Padella discussed the bills on tonight's agenda allowing for a parks advisory board or committee vs. a full parks board. He shared pros and cons for such.

It was noted the updated conflicts of interest ordinance is due back to the Mo Ethic Commission by September 15th. Alderman Guccione moved to suspend the rules for Bills 25-040. Alderman Holt seconded the motion. Motion was carried by affirmative votes of three (3) Aldermen. There were no nay votes and no abstentions.

B. Police Chief

Chief Dave McCune was present for the meeting. Nothing further at this time.

C. City Clerk/Treasurer

Amy Lewis, City Clerk - Treasurer – provided a bill list and minutes.

D. City Attorney
