The property owners John and Tami Powers were present for the meeting. Mr. Powers stated the building is about 2400 square feet with 2 bathrooms and dates back to 1999. He stated he has new tenants that plan to use the divided first floor and have agreed to share the first-floor restroom. One tenant on the first floor would be an HVAC office and the other would be a photography studio that would also offer a small event space when it is not in use for bridal showers, birthday parties, or small meetings. It was noted the max occupancy of the space is 49. There are no plans for a kitchen at this time.
