BOARD OF ALDERMEN REGULAR SESSION MINUTES  
MONDAY DECEMBER 8, 2025**

- C. Bill No. 25-052 – An Ordinance of the City of Cottleville, Missouri, Approving an Intergovernmental Cooperative Agreement Between the City of Cottleville, Missouri, and the City of St. Peters, Missouri, Providing for Solid Waste Collection Services and Matters Related Thereto.

Alderman Krekeler moved for the second reading of Bill # 25-052 as amended. **An Ordinance of the City of Cottleville, Missouri, Approving an Intergovernmental Cooperative Agreement Between the City of Cottleville, Missouri, and the City of St. Peters, Missouri, Providing for Solid Waste Collection Services and Matters Related Thereto.** Alderman Gnau seconded the motion. There were no nay votes and no abstentions

Discussion was held regarding the length of the agreement with St. Peters for waste hauling services. It was noted there was no rate increase in 2026. It was further noted that St. Peter’s goal is no rate increase for waste hauling in 2027 as well, but it’s not a guarantee in the agreement which expires at the end of the year. Discussion regarding St. Peters is now providing a more efficient all-inclusive service featuring new trucks with cameras and single-stream recycling which could assist with keeping rates down in the future. Alderman Holt stated she wanted to review other rates and carriers further again since she has seen rate increases in the past. Alderman Gnau and Micheal Padella, City Administrator stated that has already been explored and noted the agreement is expiring soon. Mr. Padella stated he would explore a 3-year agreement with St. Peters but did not believe they would entertain such as a 5-year agreement was requested for the infrastructure pay out. Mr. Padella also noted St. Peters has allowed multifamily including Avalon senior living complex to seek their own carrier in this new agreement. Chief McCune shared his rates from the City of O’Fallon which were similar but not all inclusive.

Alderman Krekeler moved to table Bill 25-052. Alderman Holt seconded the motion. Motion was carried by affirmative votes of four (4) Aldermen. There were no nay votes and no abstentions

Alderman Guccione moved to remove Bill 25-042 from the table. Alderman Gnau seconded the motion. Motion was carried by affirmative votes of four (4) Aldermen. There were no nay votes and no abstentions.

Discussion was held regarding the permanent utility easements requested by Spire gas infrastructure improvement project who is offering to compensate the City for such. Mr. Padella shared 3 new location options for their ground bed with the Mayor and Board of Aldermen. It was the consensus of the Board of Aldermen to choose location labeled #1. Some discussion was held regarding what level of property maintenance Spire might do.

Alderman Guccione moved to table Bill 25-042. Alderman Gnau seconded the motion. Motion was carried by affirmative votes of four (4) Aldermen. There were no nay votes and no abstentions.




#### **Adjournment of Meeting**

The budget and its overview included; employees raises with a cola, police equipment and technology support, new IT investments, new parks maintenance positions, park improvements and new amenities, trail maintenance connections, lake and bank stabilization projects, new police and public works vehicles, completing comp plan updates, streets and sidewalk repairs or improvements, parking enhancements, and engineering.


