

(Adds and defines a new weed height limitation for right-of-way consisting of $\frac{3}{4}$ acre of continuous area.)

Bill No. 26-011 – An Ordinance of the City of Cottleville, Missouri, Amending Subsection C.4 of Section 230.060 “City Solid Waste Service” of the Municipal Code of the City of Cottleville, Missouri, by Deleting it in its Entirety, and, In Lieu Thereof, Enacting a New Subsection C.4 of Section 230.060 “City Solid Waste Service”. (Reduces the penalty charges for delinquent accounts from 20% to 10% of the total delinquent amount outstanding.)
