The Board of Aldermen held their meeting in the City Hall boardroom located at 5490 5th Street Cottleville, Missouri.

Mayor Stephen Thompspon called the meeting top order at 7:05pm.

Alderman Guccione moved to amend the agenda;

Alderman Holt stated she appreciate dall the behind the scenes work the City staff does to support St. Patrick's Day and Irishfest around the City.

Alderman Holt moved to continue the public hearing item A. Alderman Krekeler seconded the motion. Motion was carried by affirmative votes of four (4) Aldermen. There were no nay votes and no abstentions.

Alderman Holt moved to open the public hearing item C. Alderman Gnau seconded the motion. Motion was carried by affirmative votes of four (4) Aldermen. There were no nay votes and no abstentions.

The applicant, Mr. Barnhart stated that there are currently 500 Sparkles locations nationwide. He stated the facility will include six grooming tables, six tubs, and a small waiting area by appointment only. He further stated that dogs will not be kenneled and are not expected to wait for long periods. Alderman Holt inquired about cats. Mr. Barnhardt stated they will not service cats. Additionally, he confirmed there will be no overnight boarding. Mr. Barnhart stated the walls are specifically engineered to reduce the sound of barking dogs and they plan to have dog waste bags station. He also sated the store front will have its own independent HVAC system.

March 18, 2026

The Board of Aldermen held their meeting at City Hall located at 5490 5th Street Cottleville, Missouri.

Mayor Stephen Thompson called the meeting to order at 5:30p.m.

Staff Reports

City Administrator

During the meeting, City Administrator Michael Padella reviewed the agenda items with the Mayor and Board of Aldermen, including the public hearings and consent agenda items.

A discussion was held regarding the repair of the damaged Vantage Lake Trail during the bank stabilization project. The Board of Aldermen considered whether to pay the difference to upgrade portions of the trail to current standards or to have the contractor perform a standard 2-inch overlay on the trail. It was noted that the previous standard overlay lasted 10–15 years and that the Parks and Recreation Advisory Committee (PRAC) had recommended approving the upgrade, pending final costs.

Those costs have since been finalized at \$78,153.56. Following review, it was the consensus of the Board of Aldermen not to pay the difference of \$78,153.56 for the upgrade.

Mr. Padella reviewed the Resolution 26-03 on tonight's agenda opposing Missouri House Bill 2429 requiring municipalities pay for broadband utility relocation.

Police Chief

Chief Dave McCune was present at the meeting and outlined the reasons for trading-in the recently purchased of Mini Cooper for a Ford Explorer that will be used by the Warren Elementary SRO. Chief McCune also reported the new camera system has assisted with solving the Crown Luxury Resale store break in.

City Clerk/Treasurer

Amy Lewis, City Clerk - Treasurer – provided a bill list, the non-binding property tax levy, sample business letters and minutes. Mrs. Lewis also reported the first senior bingos partnering with the CWS Rotary Club were a success as well as the first St. Charles Historical Society Cottleville Chapter kick off meeting. She further noted she attended the first PRAC meeting and took the minutes of which she noted a lot of enthusiasm among the members.

City Attorney

Drew Weber, City Attorney, was present for the meeting. Nothing further at this time.

Communications from the Alderman

St. Charles Street Connector Sidewalk Project

Alderman Krekeler inquired about the St. Charles Street connector sidewalk. Mr. Padella reported that the project has been assigned to an engineering firm and design work is currently underway.

Mr. Padella also noted that the same firm is working on the design for additional parking spaces throughout the Old Town Cottleville area.

Alderman Holt thanked the Clerk's office for addressing business noise and temporary signs via written notification. Mrs. Holt also inquired about enforcement of electric scooters as she is still seeing dangerous activity. Mrs. Holt also requested a visit from the PD K9.

Communications of the Mayor

Mayor Thompson encouraged the Board of Aldermen to participate in writing blogs that will be posted on the City's website. He also mentioned he would like to allow more zoom attendance options.

After reviewing the aerial views of the area, Mr. Padella reported that the engineering firm is evaluating the west and north sides of the street for the installation of sidewalks and a pedestrian crossing.

Impact City FC Proposed Indoor/Outdoor Soccer Facilities - Traffic Study Results & Discussion.

Mr. Padella has reported that the traffic study is currently under review. The study does indicate that a traffic signal is warranted at this location. Mr. Padella will discuss this further with the applicant.
