**BOARD OF ALDERMEN REGULAR SESSION MINUTES**  
**WEDNESDAY, SEPTEMBER 17, 2025**

The Board of Aldermen held their meeting in the City Hall boardroom located at 5490 5<sup>th</sup> Street Cottleville, Missouri.

Mayor Stephen Thompson called the meeting to order at 7:08 p.m. and the pledge of allegiance was recited.

There were four (4) members present and zero (0) absent.

**Mayor's Report**

Mayor Thompson announced that Missouri Municipal League conference attendees elected to tour Cottleville on Sunday. He thanked the sponsors, Sheriff Lewis and City staff for participating and showcasing the City.

A. Proclamation Recognizing the United States of America's Constitution Week.

During this time a proclamation recognizing constitution week was presented to members of the Daughters of the American Revolution local chapter.

B. Proclamation Recognizing National POW/MIA Remembrance Day.

During this time a proclamation was presented recognizing National POW/MIA Remembrance Day. Cottleville resident Eric Larson donated supplies for a "Missing Man Table" which is set up in the City Hall lobby. He also read aloud the meaning of each item on the table.

C. Appointment to Old Town Historic Commission.

Alderman Krekeler moved to approve the appointment Melissa Tasios to the Old Town Historic Commission to fill a vacancy for an unexpired term through 6/1/27. C above. Alderman Gnau seconded the motion. Motion was carried by affirmative votes of four (4) Aldermen. There were no nay votes and no abstentions.

**Board of Aldermen's Report**

**Public Hearings**

A. A Public Hearing for the Consideration of a Moratorium on the Acceptance and Review of Applications for the Rezoning of Property to Planned Unit Development (PUD) in the City of Cottleville, Missouri, Pending the Commission's Study and Review of Policies, Regulations, and Standards Pertaining thereto.

Alderman Holt moved to open public hearing item A above. Alderman Gnau seconded the motion. Motion was carried by affirmative votes of four (4) Aldermen. There were no nay votes and no abstentions.

Nancy McConnell, owner of Stone Soup Cottage also residing at 348 Round Tower spoke to the Mayor and Board of Aldermen about how a moratorium has and will affect her and her property rights. Mrs. McConnell stated she has worked for 16 years, 12 hours a day to be able to afford to buy the 32 acres of Wiese Farm. She stated she has met with the City Administrator and Mayor several times regarding her desire to develop an upscale Agri-hood including luxury free standing French style villas that would complement the Cottage and the Farm. However, she has recently lost two real estate contracts including some earnest money due to rumors of the City implementing some kind of moratorium soon. She further stated she does not desire any apartments or high rises. She noted the constitutional rights of land owners and their property rights to use their land should be considered and therefore she requested the Board of Aldermen stop the moratorium and the rumors regarding the same.

Alderman Holt moved to close public hearing item A above. Alderman Gnau seconded the motion. Motion was carried by affirmative votes of four (4) Aldermen. There were no nay votes and no abstentions.

The Board of Aldermen held their meeting at City Hall located at 5490 5<sup>th</sup> Street Cottleville, Missouri.

Mayor Thompson called the meeting to order at 5:32p.m.

There were four (4) members present and zero (0) absent.

**Staff Reports**

A. City Administrator

During this time, Michael Padella, City Administrator, updated the Board of Aldermen on all agenda items including the consent agenda items, proclamations and both public hearing items. Discussion and review was held regarding the pros and cons of putting a moratorium in place and the message it could send to other businesses considering locating in Cottleville as well as the impact it may have now or in the future on the City. However, it was noted it would allow time for the comp plan to be completed which cost \$110,000.00. Alderman Gnau pointed out the Planning and Zoning Commission recommend that the moratorium be denied. He also stated he would hate for there to be any missed opportunities for the City due to placing a moratorium that might be misunderstood especially when the City can currently deny any rezonings already. Drew Weber, City Attorney provided some insight on moratoriums in the area, and the rights landowners have. He stated cities should not do blanket moratoriums because if it were challenged in court that City would lose. Mr. Padella noted on tonight's agenda is a moratorium on PUDs only. Alderman Holt stated she would like a moratorium to be in place until the updated comprehensive plan is finished. Mayor Thompson stated applications can be reviewed that have been recently submitted. It was noted there is a waiver process after 90 days in tonight's Bill regarding a moratorium. Alderman Krekeler stated everyone wants to be here and there is too much traffic, too much development and he said a moratorium would slow it all down. Alderman Guccione also mentioned that PUD and rezonings can be denied currently and inquired if any feedback has been received on this matter.

Alderman Holt moved to table Bills 25-029 and 25-030 at the applicants request while they are having a traffic study done. Alderman Holt seconded the motion. Motion was carried by affirmative votes of four (4) Aldermen. There were no nay votes and no abstentions.

Alderman Holt inquired if there was an alternative location or if the size could be reduced for the additional Spire pipeline easement needed. Alderman Gnau stated it may be needed for grounding purposes.

During this time, Mr. Padella continued to review the bills on tonight's agenda relating to any code changes. The Board of Aldermen then discussed the request on tonight's agenda to sell liquor at 5208 Highway N, Men's Modern General Store. It was noted the applicant wishes to sell small batch liquors not found in big box stores and the bill tonight limits liquor sales to 50% or less of the total sales and can only be displayed on 10% or less of floor space. Alderman Krekeler and Alderman Holt inquired if wall space is counted.

Alderman Krekeler and Alderman Holt stated they have gotten noise complaints. Chief Dave McCune reiterated what he would like residents to do if they need to make a noise complaint which is call the 24 hours dispatch at 636-939-9966 when it is happening because the police department has only received a



few to date. Alderman Krekeler stated he has his own decibel reader and has been driving around the old town area reading levels. He requested venues install self-monitoring and reporting systems.

**B. Police Chief**

Chief Dave McCune was present for the meeting. Nothing further at this time.

**C. City Clerk/Treasurer**

Amy Lewis, City Clerk - Treasurer – provided a bill list, minutes and property tax proforma. She further stated the proforma is due back to St. Charles County later this month.

Alderman Guccione moved to suspend the rules for Bills 25-047. Alderman Holt seconded the motion. Motion was carried by affirmative votes of four (4) Aldermen. There were no nay votes and no abstentions.
