Staff Reports

A. City Attorney

Drew Weber, the City Attorney stated he is still waiting for hearing dates on the 2 pending litigation matters.

B. City Administrator & Public Works Director

Mr. Francis introduced Cottleville's future City Administrator, Mike Padella, who was present for the meeting.

Rich Francis, City Administrator, reviewed the consent agenda, and other agenda items such as: the building elevations, rezoning and conditional use request for On the Rocks to be located at the southeast corner of Gutermuth Road and Highway 364. Mr. Francis provided information regarding the 2 escrow releases on tonight's agenda. He also reviewed the other agenda items such as the resolution providing for the sample ballot for the April 2_{nd} election as well as the new building codes in relation to using county services for monitoring blasting, septic systems arid rebuilding after any natural disasters.

Mr. Francis showed the Board a new website the county provides showing where the snowplows are working at in real time. He stated he monitored that during the last sto1m.

C. Chief of Police

Dave McCune, Police Chief, reported a new officer will begin soon that was previously employed with the City of Warrenton. He also reported a new part time records clerk has begun. In addition, Chief McCune stated he was hopeful 2 recruits from the police academy will fill the other 2 vacancies possibly in April. Alderman Gnau inquired about the length of any probationary and training period for newly hired police officers which is 12 months at CPD.

Lastly, Chief McCune stated the new police k9 dog "Bach" is working out well with CPD.

D. City Clerk/Treasurer

Amy Lewis, City Clerk - Treasurer provided a bill list, updated sales tax chart and minutes.

Communications from the Alderman

Alde1man Krekeler discussed the use of the newly completed parking areas in and around city hall and Legacy Park. He also inquired about the damage stamped concrete at Lorenzo's Plaza. Mr. Francis stated some of the damage was already existing prior to nearby construction. However, the adjacent property owner plans to pay for a poltion of the repairs.

Lastly, Alderman Krekeler stated he wanted to plant wildflowers at the base of the pedestrian bridge over Dardenne Creek in Legacy Park that won't require any maintenance. He also stated he wanted to clear out more trees in Legacy Park but leave the valuable trees.
