# CITY OF COTTLEVILLE BOARD OF ALDERMEN REGULAR SESSION MINUTES WEDNESDAY, MAY 21, 2025

The Board of Aldermen held their meeting in the City Hall boardroom located at 5490 5th Street Cottleville, Missouri.

Mayor Stephen Thompson called the meeting to order at 7:45 p.m.

#### 4. Mayor's Report

Mayor Thompson announced the City is accepting applications from residents who are interested in serving on various City boards and commissions or for other miscellaneous volunteer opportunities to help serve the community.

## 6. Public Hearing

A. A Public Hearing for a Request for Rezoning of an 18.70-acre tract of land located at 2 Woodlands Parkway, in Cottleville, MO 63376, from SD/C-C2 "College General Commercial Subdistrict" & SD/C-PO "College Park and Open Space Subdistrict" to RD "Recreational District" ("Vetta Woodlands", Project Name; Woodlands Parkway LLC, Applicant).

Alderman Guccione moved to open public hearing item A. Alderman Gnau seconded the motion. Motion was carried by affirmative votes of four (4) Aldermen. There were no nay votes and no abstentions.

David Vonarx with Vonarx Engineering was present at the meeting to discuss their application to reduce the number of fields from 5 to 3 at 2 Woodlands Parkway. They plan to turf the fields and add new and improved lighting, offering little to no light pollution. A lighting impact study was provided. In addition, they plan to add over 400 paved parking spaces and landscaping. The applicants stated the condo's adjacent to them should not receive light "pollution" from the new enhanced lighting. It was noted that the condo owners and HOA have been notified, and no comments have been received to date. It was noteed their hours of operation would be until about 9:30pm.

Alderman Guccione moved to close public hearing item A. Alderman Holt seconded the motion. Motion was carried by affirmative votes of four (4) Aldermen. There were no nay votes and no abstentions.

B. A Public Hearing for a Request for Conditional Use Permit (CUP) "outdoor soccer fields, with lights" at 2 Woodlands Parkway, in Cottleville, MO 63376 ("Vetta Woodlands", Project Name; Woodlands Parkway LLC, Applicant).

Alderman Guccione moved to open public hearing item B. Alderman Holt seconded the motion. Motion was carried by affirmative votes of four (4) Aldermen. There were no nay votes and no abstentions. Nothing further.

Alderman Guccione moved to close public hearing item B. Alderman Krekeler seconded the motion. Motion was carried by affirmative votes of four (4) Alderman. There were no nay votes and no abstentions.

C. A Public Hearing for a Request to Renew the Conditional Use Permit (CUP) "to allow for package liquor sales" at 5430 Gutermuth Road in Cottleville, MO 63304 ("On-The-Rocks", Project Name; ARP Properties, LLC, Applicant).

Alderman Gnau moved to open public hearing item C. Alderman Holt seconded the motion. Motion was carried by affirmative votes of four (4) Aldermen. There were no nay votes and no abstentions.

It was noted applicants have requested to withdraw their application and have indicated they are cancelling the entire project.

Alderman Guccione moved to close public hearing item C. Alderman Holt seconded the motion. Motion was carried by affirmative votes of four (4) Aldermen. There were no nay votes and no abstentions.

D. A Public Hearing for a Request to Amend the PUD Area Plan for the Cottleville Trails subdivision located east of Hwy 364, South and West of Hwy N, North of Gutermuth Road ("Cottleville Trails", Project Name; DCM Land, LLC, Applicant).

Alderman Guccione moved to open public hearing item D. Alderman Gnau seconded the motion. Motion was carried by affirmative votes of four (4) Aldermen. There were no nay votes and no abstentions.

Jeff Simmons with Bax Engineering, Elizabeth Lum with Amundsen Davis and the landowners were present for the meeting to describe their amendments and requests tonight. It was noted the two pools would now exceed 4800 square feet with room for about 100 loungers around the pool. The applicant provided a sketch or drawing regarding the same. The applicant requested they would like to get started on the pool and landscaping. The beach size has been increased. Mr. Simmons stated the plans include increased street width and driveway approaches and some trails, sidewalks, parking lots, drive lanes and buildings have had minor geometric changes or have been reoriented. The lake shape has changed slightly as well. The plans also include a welded bridge between lake 6 and 7. Plans also include covered enclosed golf cart parking, one with a farmhouse look and the other slightly more modern look. Pavilions, picnic tables and fire pits remain but two pavilions are smaller, and BBQ pits have been removed. The main playground area has increased, and the applicant has met with the residents to pick out the equipment.

Mr. Simmons stated Village H would offer 117 town homes for sale and provided elevations for both Village H and I of which one has a white farmhouse look and the other a more modern look with earth tones. Alderman Guccione inquired about the number of public parking spaces in the new villages. Mr. Simmons stated parking has increased and it was noted construction would start on Village H first.

Mary Stull, 9094 Camino Trail spoke in favor of the new Cottleville Trails amendments.

Mark Wichern, 6020 St. Charles Street stated he was representing 20-30 residents of Cottleville Trails residents that are in favor of the new amendments presented.

Jamie Goodwin, 6013 St. Charles Street stated she is also happy with the plan but recognized more resources need to become available for erosion control and improvements.

Alderman Krekeler inquired about the pedestrian bridge over Dardenne Creek.

Mr. Weber, City Attorney, clarified the new pedestrian bridge over the Dardenne Creek was removed last fall while preserving the corridor to evaluate for a road and bridge and the pedestrian bridge would be in conjunction with any new bridge that should it be built. However, if not, the pedestrian bridge would be reinserted into the plan to be built by the developer.

Alderman Guccione inquired about the historic bridge once on the property, Mr. Kolb, the applicant stated some of the bridge abutment stone would be used at the welded bridge between lake 6 and 7 but there was

some stones and iron beams left. He also stated he is aware of the historical significance of the bridge and plans to place a plaque near the stone he uses.

Mr. Kolb, the applicant, stated he has a punch list of items with the residents before the HOA would take over and erosion remedies is included on that list and still being worked on.

Elizabeth Lum stated before the homeowners take over the punch list items would need to be completed, and a large percentage of the homes would need to be sold and built.

Alderman Guccione moved to close public hearing item D. Alderman Krekeler seconded the motion. Motion was carried by affirmative votes of four (4) Aldermen. There were no nay votes and no abstentions.

# CITY OF COTTLEVILLE BOARD OF ALDERMEN WORK SESSION MINUTES MAY 21, 2025

The Board of Aldermen held their meeting at City Hall located at 5490 5th Street Cottleville, Missouri.

Mayor Ronkoski called the meeting to order at 6:00p.m.

There were four (4) members present and zero (0) absent.

## **Staff Reports**

### A. City Administrator

During this time, Michael Padella, City Administrator, updated the Board of Aldermen on the agenda items including the public hearings. He reviewed the plan for improved new outdoor lighting being added to the 3 new turf fields at 2 Woodlands Parkway. Mr. Padella also announced the applicant for On the Rocks at 5430 Gutermuth Road withdrew their application citing the process had become too difficult. Discussion was held regarding the zoning and conditional use application process and its expiration dates. Mr. Padella reviewed the amendments to PUD for Cottleville Trails which includ increased pool size and changes to the playground, pavilions, beaches, as well as configuration or layout changes to the lakes, trails and internal streets. It was noted the plan also adds 12 units to Village H and reduces the number of units to Village I by 6. The amendment also increases parking for the for-sale townhomes. Discussion was held regarding erosion remedies and amending the code to increase escrow amounts when detention basins are installed. Mr. Padella stated he has about 10 code changes pending and that is one of them. He plans to discuss all of them with the Board at a work session.

Alderman Krekeler inquired who reviews properties before an escrow is released. He further stated he is concerned about rocks and gravel being left on construction sites before sod is laid or grass seed is planted such as at Yuppy Puppy and Len's Auto. He commented further that asphalt, and concrete is shoved to the side of a trail in Cottleville Trails. It was noted they are still working on a punch list of items.

At this time Mr. Padella reviewed the consent agenda items which include a heat pump outage at city hall and declaring 2 vehicles as surplus property to be sold via Purple Wave Auction Company.

## B. Police Chief

Chief Dave McCune was present for the meeting. Discussion was held regarding seeking alternative police dispatching services and records management services. It was noted the current Lake St. Louis dispatching agreement expires June 30, 2025 who has been providing those services for 25 years. Chief McCune stated realistically a January 1, 2026 would be ideal if switching to a new provider for a variety of reasons such as training staff and programming equipment. Chief McCune stated he has a proposal from O'Fallon for dispatching services. Mayor Thompson inquired if he would explore obtaining a proposal from St. Peters as well. Chief McCune stated our current records management offers a read only version for \$500.00 to retain any previous records.

## C. City Clerk/Treasurer

Amy Lewis, City Clerk - Treasurer - provided a treasurer report, bill list, and minutes.

Discussion was held at this time regarding the City's vendor licenses and the process to obtain such licenses to vend within the city limits of Cottleville. It was noted the application process includes providing a no tax due letter for renewals. Mr. Weber, City Attorney, stated all vendors must be treated the same whether they're vending from a truck, trailer or tent. The City Clerk and Mayor stated we have received complaints regarding the vending license process becoming too much *red tape* for the average vendor selling homemade goods such as honey, soap, jewelry, clothing, crafts etc. It was noted it is discouraging pop-up type markets or events that include vendors therefore the City needs to decide how to proceed in the future. This discussion will continue at the future meeting.

#### D. City Attorney

Drew Weber, City Attorney was present for the meeting. Nothing further at this time.

#### Communications from the Alderman

Alderman Johnny Gnau stated it has been brought to his attention that a local business owner has accused him of an ethics violation by voting to allow their neighbor the use of a utility easement for sewer connection (that was ultimately granted by Duckett Creek Sanitary District) after he won an HVAC bid on the neighboring project nearly a year earlier. Mr. Weber, City Attorney, stated that it did not constitute a Missouri Ethics violation in his opinion. Alderman Gnau stated he fears backlash to his business and although he feels it is not fair to his employees to not receive the work, he has withdrawn his bid to install a new heat pump at City Hall which was a lower bid than the one on tonight's consent agenda.

Alderman Holt stated she wished to discuss the noise ordinance regarding live music. Alderman Krekeler stated he drove through town with his windows down and could hear the bands. He further requested a decibel meter be installed monitoring the sound levels at each establishment. Chief McCune stated he received one complaint regarding live music noise through dispatch over the weekend. Chief McCune again requested that the public and board members call in their noise complaints so a decibel meter reading can be taken from the complaint's location with the City's calibrated device and a warning or violation issued if it is over the decibels allowed per city code and OSHA regulations. Chief McCune stated it is important that the decibel meter reading be taken from the complainant's location. Mr. Weber, City Attorney, agreed that noise violations are usually complaint base driven.
