Above Twenty-Five (25) Square Yards \$250.00
Plus an additional \$5/S.Y. above 25 S.Y.

12. SMALL WIRELESS APPLICATION(S)

- a) The total fee for an application for the collocation of a small wireless facility on an existing City pole is \$100 per small wireless facility
- b) An applicant filing a consolidation application shall pay \$100 per small wireless facility included in the consolidation application
- c) The total fee for an application for the installation, modification, or replacement of a utility pole and the collocation of an associated small wireless facility is \$500 per utility pole
- d) The rate for collocation of a small wireless facility to a City pole is \$150 per City pole per year

Notes:

- 1. All fees apply to the initial submittal and one (1) resubmittal in response to initial review comments. Subsequent submittals beyond the first two (2) may be charged additional fees for the actual time and expenses of the City Engineer at the charge out rates and fee schedule effective upon the date of subsequent reviews.
