New Business

A. Certificate of Appropriateness for a new sign at Frankie Martin Food Garden.

Rich Francis, City Administrator presented Frank Martins Garden proposed sign made of wood with metal hardware that will hang by a wooden arm/hanger. It was noted ground lighting would be used and the lettering would feature a wood burnt font style. The sign will be located on the corner of their property at Highway N and St. Charles Street. The Commission requested the sign not block the view of any traffic. Terry Hogan requested "Established 2022" be added to the sign.

B. Certificate of Appropriateness for a new building addition for Cottleville Community Fire Protection District.

Mr. Francis stated the fire department is going to make major renovations to their existing buildings and add a new 3,597 sf addition. The living quarters will have the interior completely remodeled. The addition will eliminate some parking spaces on the south side of the administration building and the main entrance will be toward the rear. The driveway will remain. The new building addition will have new windows and match the existing brick and roof colors.

Pat Kelly moved to approve item B above. Gina Ralston seconded the motion. Motion was carried by affirmative votes of five (5) members. There was no nay votes and no abstentions.

B. Certificate of Appropriateness for a new sign at 5381 Highway N.

Mr. Francis provided a copy of the new white sign for Narrative Realty that will hang on the corner of 5381 Highway N from a bracket. It was noted this bracket was used by other tenants of the building.

Terry Hogan moved to approve item C above. Gina Ralston seconded the motion. Motion was carried by affirmative votes of five (5) members. There was no nay votes and no abstentions.
