Staff Reports

a.) City Attorney

Drew Weber, City Attorney was present for the meeting and reported he has drafted a new ordinance complying with state regarding refrigerants.

b.) City Administrator & Public Works Director

Rich Francis, City Administrator, reviewed the consent agenda and all other agenda items for tonight's meeting with the Board of Aldermen. Mr. Francis also provided revised elevations for the new swim school to the Board of Aldermen. It was noted the building may be expanded later. The new elevations include siding, stone, and brick.

Discussion and review were held regarding the final site plan for Prairie Bluffs, as well as adding stand up paddle boards to the rentfun.com contract. Mr. Francis also updated the Board on the Gutermuth Road improvements that St. Charles County Government is doing. Mr. Francis hoped to obtain more information from the County soon regarding the same.

Mr. Francis provided a timeline and history of the Cottleville Trails subdivision particularly for the new Aldermen, but it was an informative update for everyone. It was noted tonight's record plats were in relation to Cottleville Trail's individual lots.

During this time Mr. Francis provided a brief report on the City's approximately 3 million in CD investments which are all being renewed at better interest rates.

Mr. Francis reminded the Board of Aldermen of the upcoming repairs to the stamped crosswalks in the old town Cottleville area and the asphalt repaving of the parking lot drive isle around City Hall. He also reminded the Board of Aldermen about the St. Joseph Spirit Day Parade and that the CFD plans to close part of the road next week for their building construction project.

c.) Chief of Police

Chief Steve James stated recently the CPD D.A.R.E graduations were held. He further reported Officer Tim Dunsford received an award from MADD.

d.) City Clerk/Treasurer

Amy Lewis, City Clerk/Treasurer, provided minutes, an updated sales tax chart, a Treasurer Report and a list

of expenditures. Mrs. Lewis further noted the work continues to produce the audited financial statement for 12/31/2022 with the City Auditor.
