#### Approval of Minutes

Alderman Mike Guccione moved to approve the minutes from November 6, 2023 meeting. Pat Kelly seconded the motion. Motion was carried by affirmative votes of six (6) members. There were no nay votes and no abstentions.

#### **New Business**

A. A Public Hearing and Consideration of a Rezoning Request from ARP Properties LLC to Rezone the Southeast Corner of Gutermuth Road and Highway 364 from C-1 Light Commercial Office to C-3 General Commercial Retail.

Mr. Patel the applicant along with Chris Kaylen from United Construction were present for the meeting to present his plan to operate "On the Rocks" liquor store and mini mart at the above location therefore requesting a rezoning, conditional use permit and site plan approval. The applicant stated it would be an approximately 7000 square foot flat roof, stucco building with some stone. The building will be 1 unit and would feature two signs. The applicant encouraged the members to visit his St. Charles location. Currently he plans to have hours of operation such as 9am-10pm on weekdays and until Midnight on Friday and Saturdays. He also said he plans to offer items wanted by those living in the Avalon Senior Living such as bread, milk etc.

It was the consensus of the Commission there was not enough stone on the building. Terry Hogan suggested showing the material sample to the Board of Aldermen. The applicant stated they plan

to install fast growing large "Little Giant" trees along the rear property line along with fencing and a possible retaining wall if needed, all with City staff approval. It was noted that a lighting plan and a landscape plan would need to be submitted to the City for approval. It was the consensus of the Commission to require stone on 3 sides of the building at sill height. It was also the consensus of the Commission that the trash dumpster enclosure matches the building.

John Welch, of 460 Fox Trail Dr Lake St. Louis Mo stated he has concerns regarding light pollution, traffic, landscape buffering vs fencing and feared it becoming a bad area for children. However, Mr. Welch stated he had worked out some of his concerns with the applicant and hoped to meet with them again in the future.

Terry Hogan moved to close public hearing item A above. Alderman Mike Guccione seconded the motion. Motion was carried by affirmative votes of six (6) members. There were no nay votes and no abstentions.

Terry Hogan moved to approve item A above contingent upon all three sides of the building including stone at sill height and a lighting and landscape plan is submitted to the City for staff approval. Terry Hogan seconded the motion. Motion was carried by affirmative votes of six (6) members. There were no nay votes and no abstentions.

B. A Public Hearing and Consideration of a Conditional Use Permit Request from ARP Properties LLC to Operate a Packaged Liquor Store at the Southeast Corner of Gutermuth Road and Highway 364.

Terry Hogan moved to close public hearing item B above. Alderman Mike Guccione seconded the motion. Motion was carried by affirmative votes of six (6) members. There were no nay votes and no abstentions.
