### **New Business**

A. Public Hearing for a Request for Rezoning of a 23.854-acre tract of land north of St. Charles Street and west of Crooked Creek, in Cottleville, MO 63304, from Single-Family Residential District (R-1A (1 acre)) to Single-Family Residential District (R-1C (1/3 acre), (Lombardo Homes St. Louis, Applicant).

Alderman Guccione moved to open public hearing item A. Stepehen East seconded the motion. Motion was carried by affirmative votes of four (4) members. There were no nay votes and no abstentions.

Steven Valentine with Lombado Homes, was present for the meeting to discuss this new application for the location above which will now feature 10 home lots offering 3+ car side entry garages and a price point close to \$1,500,000. He further noted the lots sizes have a average of about 21,000 square feet ranging from 15,000 to 41,000.

Mr. Valentine presented a slide show of the quality water basins they have been building for 15 years in other communities that do not fail. He stated they work with DJM Ecological Services to properly construct the basins as well as planting appropriate plants that have very deep stable root systems. He further stated he felt that rip rap is an eyesore and grows mold, weeds and collects trash. He didn't feel these 1.5 million dollar homes would want a rip rap rock bank.
