## **ROLL-OFF / DUMPSTER REQUEST FORM**

If you are working on a major remodel, getting rid of things in preparation of moving, tearing down a fence or any other type of large project, a roll-off container may be just what you need.

## Fees

Cottleville residents can rent a roll-off for seven (7) days for \$400. The fee includes delivery, pickup, and up to four (4) tons of trash. Payment is due at the time of scheduling.

If you need it longer than that or have more than four tons, no problem! Each additional ton is charged at \$50/ton. Each additional day is charged at \$25/day (March-August) or \$10/day (January, February, September-December).

Fees for appliances are in addition to the charges mentioned above. The charge is \$23 for each appliance. Appliances should be placed outside of the roll-off.

**Haul Away** - Call 636-498-6565 x 4 or email, <a href="mailto:linday.jones@cityofcottleville.com">linday.jones@cityofcottleville.com</a> to schedule the roll off to be picked up. If the truck arrives to deliver or pick up the roll off, and the driveway is not clear of any items or the roll off is blocked, an additional \$50 charge will occur.

## Restrictions

The following items are identified as prohibited and cannot be placed in the roll-off container:

Tires, paint cans containing paint, engine oil or other petroleum-based flammable liquids, asbestos, sealed barrels or drums, compressed or inert gas bottles or containers.

**Yard waste:** Must be placed in a dedicated roll-off container and cannot be mixed in with Solid Waste. A separate roll-off container can be ordered specifically for yard waste. Please note logs greater than 20" in diameter must be cut to 2' lengths or shorter, and no logs over 28" in diameter or stumps can be placed in the roll-off container and the yard waste cannot be mixed with dirt.

**Concrete and Dirt:** If you are ordering a roll-off container for concrete, dirt, or stone, the container cannot be filled over 1/3<sup>rd</sup> of the capacity.

If the roll-off container is filled beyond the top line of the dumpster, or filled beyond the 1/3<sup>rd</sup> line with; concrete, dirt, or stone, the container will not be picked up until the overage is removed and a \$50 service fee will be charged.

If the roll-off container is mixed with yard waste or contains any of the prohibited items listed above, the container will not be picked up until the items are removed and a \$50 service fee will be charged.

All roll-off containers will be inspected prior to pick-up and you will be contacted if a service fee applies. \*Please note, no amount of any of these items will be accepted.

(For example, if one limb is thrown into the container of solid waste, it will not be picked up).
