


**Adjournment of Meeting**

**JUNE 18, 2025**

The Board of Aldermen held their meeting at City Hall located at 5490 5<sup>th</sup> Street Cottleville, Missouri.

Mayor Thompson called the meeting to order at 5:30p.m.

There were four (4) members present and zero (0) absent.

**Staff Reports**

A. City Administrator

During this time, Michael Padella, City Administrator, updated the Board of Aldermen on all agenda items including the consent agenda items. It was noted Everline will be striping Weiss Road and a portion will be reimbursed from E. Meier due to an asphalt sealer spill last year. As requested by Mayor Thompson the City Attorney has prepared a prayer policy which is on tonight's agenda as Resolution 25-04. It was noted someone from the public wishing to provide an invocation at the beginning of a Board of Aldermen meeting would be allowed to do so once per 12-month period.

During this time the Mayor and Board of Aldermen discussed the amended PUD and the amenity changes to the Cottleville Trails Subdivision which is on for a final reading tonight. It was noted there is no code relating to exactly how many lounge chairs a public pool should have or how big a pavilion should be etc. Mr. Padella stated the City looked at the County's pool regulations, who provides health inspections for area public pools, and it was noted the required number of lounge chairs was comparable. Mr. Padella provided a list of 14 comments he received from Cottleville Trail residents of which 13 were in favor of the amendments. A staff memo from the City Engineer was also provided to the Board of Aldermen in May and again in June clarifying the changes and responding to various questions.

It was noted that tonight's agenda includes an ordinance for no parking signs to be permanently installed on Highway N between Wiese Road and the western boundary of the City. It was further noted O'Fallon has done the same on their portion of the Highway. In addition, there is an ordinance on tonight's agenda for a donation agreement with the City for the remaining materials of the original historical bridge that was once over Crooked Creek at St. Charles Street. Lastly, Mr. Padella that reported on tonight's agenda includes an ordinance amending the code allowing some flexibility to the start time for the Board of Aldermen meetings.

B. Police Chief

Chief Dave McCune was present for the meeting. Chief McCune provided a sound test that he did at Frankie Martin Garden over the weekend on Friday and Saturday nights while they had live bands. It was noted each reading was taken over a 2 minute period at eight different locations on their property at 3 different times. However, all readings were consistent and remained within or near OSHA recommendations. Chief McCune stated therefore, further away at residential properties the decibel levels would be further reduced. However, continued monitoring will occur. Mr. Padella noted Staff plans to have a meeting with local business owners who provide live outdoor entertainment to discuss the matter. The Mayor stated the intent is not to change the code regarding live music but rather encourage the businesses to keep sound levels down on their own.



C. City Clerk/Treasurer

Amy Lewis, City Clerk - Treasurer – provided a bill list, and minutes. Mrs. Lewis also stated City Staff are still working on the new website and that she expects training on maintaining the new website to begin in late July.

D. City Attorney

Drew Weber, City Attorney was present for the meeting. Mr. Weber stated some of the recent code changes discussed at the previous work session would be on the August Planning and Zoning meeting as well as the August Board of Aldermen meeting.

Motion was made by Alderman Guccione, seconded by Alderman Krekeler go into closed session at 6:20 p.m., pursuant to 610.021 RSMo Litigation. Motion was carried by affirmative votes of four (4) Aldermen. There were no nay votes and no abstentions. Amy Lewis, City Clerk called roll:


