

CITY OF COTTLEVILLE
BOARD OF ALDERMEN SPECIAL SESSION MINUTES
TUESDAY JUNE 10, 2025

The Board of Aldermen held their meeting in the City Hall boardroom located at 5490 5th Street Cottleville, Missouri.

Mayor Stephen Thompson called the meeting to order at 5:30 p.m and the pledge of allegiance was recited.

There were four (4) members present and zero (0) absent.

Discussion was held regarding the Cottleville Police Department's desire to move police dispatching services, prisoner housing and CAD or record management services to the City of O'Fallon by July 1st due to officer safety concerns and better equipment or services available such as a flock camera command center. Alderman Guccione stated he would like a flock camera in every Cottleville park not just Legacy Park. In addition, it was noted that the OFallon jail is closer and seems to run more efficiently therefore getting officers back in Cottleville on duty quicker. It was noted the current dispatching services contract with the City of Lake St. Louis expires on June 30th and they were only interested in renewing for no less than one year. Therefore, on tonight's agenda is ordinances relating to providing police dispatching service, prisoner confinement and police records management software beginning July 1st. It was also noted that a read only version will be requested for the current police records software from Omnigo. Lastly, Lt. Araujo stated he felt staff could be trained to use the new records software in about 3 days depending on experience.

Alderman Michael Guccione moved to suspend the rules for two readings on Bills 25-019, 20, and 21 due to the upcoming deadline. Alderman Gnau seconded the motion. Motion was carried by affirmative votes of four (4) Aldermen. There were no nay votes and no abstentions.




Adjournment of Meeting
