Subject: Request for Bid (RFB) – Purchase of new/used (like new) golf cart.

1. INTRODUCTION & PURPOSE

The City of Cottleville is requesting sealed bids from qualified vendors for the purchase of one (1) new or used (like new) four-passenger golf cart intended for municipal operations, including park operations, special events, facility maintenance, and general city use.

The City intends to award this purchase to the lowest responsive and responsible bidder meeting the minimum specifications outlined herein.

3. GENERAL REQUIREMENTS

- 1. Cart must be new or used (like new) and clearly specified if new or used.
 - Intended for municipal/commercial use.
 - Delivery to City of Cottleville, Missouri included.
 - Vendor must provide complete specifications and warranty information.
 - Pricing shall remain firm for a minimum of 60 days.

4. MINIMUM TECHNICAL SPECIFICATIONS

A. Seating & Capacity

- Minimum of Four (4) person capacity (Optional six (6) person capacity)
- Rear seat convertible to cargo bed or utility platform
- Seat belts for all seating positions

B. Power & Performance

- Electric/battery powered
- Electric carts must be minimum 48-volt system
- Maintenance-free batteries preferred
- Speed capability of 15–20 mph

• Reverse gear with audible warning

C. Chassis & Suspension

- Heavy-duty steel or aluminum frame
- Independent front suspension preferred
- Minimum ground clearance of 5 inches

D. Safety & Lighting

- Headlights and taillights
- Brake lights and turn signals
- Horn
- Driver and passenger-side mirrors
- Windshield (fixed or fold-down)

E. Tires & Wheels

- All-terrain or turf tires suitable for park and paved use
- Steel or aluminum wheels

F. Optional Upgrades/Enhancements (Should be noted on bid sheet as optional and itemized.)

- 1. Street-legal (LSV) compliance
- 2. Removable enclosed cab
- 3. Heater/fan
- 4. Emergency strobe or amber light bar
- 5. Specify availability of color and trim options and note if there is an upcharge
- 6. Six (6) person capacity option
- 7. City logo decal graphics specify if there is an upcharge

- State proximity/distance to nearest maintenance/service facility qualified to work on cart

- Warranty documentation
- Any exceptions to specifications clearly noted

10. EVALUATION CRITERIA

Bids will be evaluated based on compliance with specifications, total cost, warranty and service support, delivery timeframe, and vendor experience.

The City reserves the right to reject any or all bids, waive informalities, accept the bid deemed most advantageous to the City, or cancel this
