## ROLL-OFF / DUMPSTER REQUEST FORM

---

If you are working on a major remodel, getting rid of things in preparation of moving, tearing down a fence or any other type of large project, a roll-off container may be just what you need.

**Fees:** Cottleville residents can rent a roll-off for seven (7) days for \$400. The fee includes the selected size roll-off, delivery, pickup, and up to four (4) tons of trash. Payment is due at the time of scheduling. If you need it longer than 7 days or have more than four tons, no problem! Each additional ton is charged at \$50/ton. Each additional day is charged at **\$25/day**.

**The issued roll-off may not be kept for more than 14 consecutive days.**

**Appliances:** Fees are in addition to the charges mentioned above. The charge is \$23 for each appliance. Appliances need to be placed inside of the roll-off.

**Clear Driveway Required:** If the truck arrives to deliver or pick up the roll off, and the driveway is not completely clear of vehicles, pods, other dumpsters, etc. or the roll off is blocked upon haul away, an additional \$50 fee will occur for an unsuccessful attempt to service.

**Haul Away:** Contact the solid waste department to schedule the roll-off haul away date.

### Restrictions

The following items are identified as prohibited and *cannot* be placed in the roll-off container:

**Tires, paint cans containing paint, engine oil or other petroleum-based flammable liquids, asbestos, sealed barrels or drums, compressed or inert gas bottles or containers.**

*\*Please note, no amount of any of the prohibited items will be accepted.*

*(Example, if one limb is thrown into the container mixed with solid waste, it will not be hauled away).*

**Yard waste:** Must be placed in a dedicated roll-off container and cannot be mixed in with Solid Waste. A separate roll-off container can be ordered specifically for yard waste. Please note logs greater than 20" in diameter must be cut to 2' lengths or shorter, and no logs over 28" in diameter or stumps can be placed in the roll-off container and the yard waste cannot be mixed with dirt.

If the roll-off container is mixed with yard waste or contains any of the prohibited items listed above, the container will not be picked up until the items are removed and an additional \$50 fee will occur for an unsuccessful attempt to service.

**Concrete and Dirt:** If you are ordering a roll-off container for concrete, dirt, or stone, the container cannot be filled over 1/3<sup>rd</sup> of the capacity. If the roll-off container is filled beyond the top line of the dumpster, or filled beyond the 1/3<sup>rd</sup> line with; concrete, dirt, or stone, the container will not be picked up until the overage is removed and an additional \$50 fee will occur for an unsuccessful attempt to service.

All roll-off containers will be inspected prior to haul away and you will be contacted if an additional service fee applies.
